

GENERAL INFORMATION

reDEWce, dew suppressant and canopy moisture inhibitor, is designed to control the formation and retention of moisture on turf from dew and frost. **reDEWce** will also allow for faster turf canopy drying after irrigation, rainfall or frost. Mowing frequency and turf growth rates will contribute or detract from the efficacy of **reDEWce**. Dew suppression will last for a period of 5 to 14 days depending on areas mowed.

Apply **reDEWce** at a 0.1 to 0.3% concentration with a boom or hand sprayer to thoroughly wet the treated area.

Apply 0.5 to 1 ounce per 1,000 ft² in 2.5 gallons of water (1.5 to 3 L/ha in 1000 L) at 5 to 7 day intervals. For extended dew control, apply 1 to 2 ounces per 1,000 ft² in 5 gallons of water (3 to 6 L/ha in 2000 L) at 7 to 14 day intervals.
