APPLICATION RECOMMENDATIONS

Apply VERDE-CAL K PLUS monthly or bi-weekly.

For continued optimum growing conditions, apply 5 pounds per 1,000 ft² or 220 pounds per acre (250 kg/ha) at 30 day intervals throughout the growing season or as needed. Soil test recommendations should be followed.

When applying bi-weekly, apply 4 pounds per 1,000 ft² or 175 pounds per acre (195 kg/ha) every two weeks throughout the growing season or as needed.
